Stillwater Blues Festival 4X4 Facts

Dates: September 11-14, 2008. Hours: Thursday & Friday 6 to 11pm, Saturday: 1 to 11pm; Sunday 12 to 5pm.

Location: Stillwater Community Center 315 W. 8th, outside parking lots on east and south side of the Center.

Event Description: Eleven years ago, the Blues Festival began in the downtown area of Stillwater. Even though the event was a success, last year the festival moved to the Community Center and attendance tripled. The event has gained national attention and is the largest free music festival central Oklahoma.

Stillwater Blues Festival 4X4...four days for music offers a wide genre and styles of music. Thursday is college night and features blues, red dirt, folk and alternative rock; Friday offers blues, classic rock, and jazz; Saturday presents the blues and more blues; Sunday features blues, gospel, and country music. The festival features top local, regional and national acts. Our Blues II stage will offer smaller acts from various Oklahoma musicians.

Venders Fee: \$75 for four (4) days. Booth space is 10'x10' and may be changed if needed, for an additional cost.

Venders Setup: The vender space should be set up and ready to open by 5:30pm Thursday, September 11, 2008, and removed by 7pm Sunday, September 14, 2008. Festival staff will collect Venders Fee upon your arrival.

The event is Free to the public and provides great music, children's activities, novelty items, food, and more.

Rules: No merchandise sales are permitted. No sales of food or beverages are permitted. Raffleing or distributing or merchandise is restricted and must receive expressed written consent of **Stillwater Blues Festival 4X4** coordinator. Participants must only occupy the space provided by **Stillwater Blues Festival 4X4** during the festival hours. Upon application approval, all participants must enter into an agreement with **Stillwater Blues Festival 4X4**. All participants must abide the rules and regulations of the festival.

Stillwater Blues Festival 4X4 will assign space in advance of each event. ALL DECISIONS ARE FINAL.
