Event Description: The 11th annual Stillwater Blues Festival is the largest FREE blues festival in Oklahoma. What a great event for families in Oklahoma!

**Stillwater Blues Festival** offers two stages of entertainment to include top notch regional, local, and national blues artists. The event is FREE to the public. An estimated 7,500+ will visit the 2009 event.

**Vendors Fee:** \$100 for three (3) days. Minimum booth space is 10'x10' and may be changed if needed.

**Vendors Setup:** The vender space should be set up and ready to open by 5:00pm Friday, September 18, 2009 and removed by 7pm Sunday, September 20, 2009. Vender Fees will be collected upon your arrival.

**Rules:** No sales of food or beverages are permitted at the festival as a miscellaneous vender. Distribution of merchandise is restricted outside the areas of the designated booth space at **Stillwater Blues Festival**. Vendors shall staff the booth unless approved otherwise by Stillwater Blues Festival director. Once application is approval and payment received, this application shall act as the contract between vender and **Stillwater Blues Festival**. All participants must abide the rules and regulations of the festival.

**Stillwater Blues Festival** will assign space in advance of each event. ALL DECISIONS ARE FINAL.
